The tradition of the *Logica* annual symposia goes back more than twenty years. From the beginning, the conferences have been organized by the Institute of Philosophy of the Czech (formerly Czechoslovak) Academy of Sciences. Since 1997 the symposia have been followed by a publication in *The Logica Yearbook* series. One central principle of the 'publication policy' of this series is that the volume has to appear before the beginning of next year's conference.

You now hold in your hands the thirteenth volume of the series. The Logica Yearbook 2009 brings together various texts from mathematical and philosophical logic, the history and philosophy of logic, and natural language analysis.
